And agree that this auction be conducted by Burns & Co (hereinafter referred to as "the auctioneers") on the following terms and conditions namely –

- The vendor agrees to pay the auctioneers entry fee of \$550 including GST per entry. An invoice will be forwarded to you for payment. Should the entry sell, the \$550 entry fee is deducted from the total commission. Should the entry not sell, the \$550 entry fee is retained by the auctioneer.
- Upon receipt and inspection of the motor vehicle, the auctioneer may deem the vehicle requires a working battery, detailing or any other extra services to ensure it is well presented for auction. These expenses are solely the responsibility of the vendor. No expense will be incurred without the vendor first being consulted by the auctioneer. Any expense incurred and agreed on, will be deducted from the sale proceeds, or in the event of no sale, all expenses will require payment before the vehicle is released. A copy of all invoices associated with these expenses will be provided.
- The vendor agrees to reimburse the auctioneer any costs incurred to transport a vehicle, and have it delivered to the auction house.
- The Vendor can set a realistic reserve on the entry/s, however, the auctioneer should be consulted with before doing so. Any transport cost incurred, will be deducted from the sale proceeds, or in the event of no sale, all expenses will require payment before the vehicle is released. A copy of all invoices associated with transport costs will be provided.
- The vendor covenants the auctioneer that all goods offered for sale at this auction are not subject to any hire purchase agreement, bill of sale, or any other legal restraint with regard to their sale and are the sole property of the vendor.
- The vendor agrees to pay the auctioneers commission on all goods sold whether at auction or by private treaty as aforesaid and at the rate of 11% including GST.
- The auctioneer's sale ledger shall be deemed to be the only true and accurate record of the auction, and the sole instrument for accounting for sale proceeds by way of account sales of the goods sold at auction.
